Smart Money Management: The Consequences of Commingling Funds

Many entrepreneurs early in the start-up phase of the business lifecycle will be inclined to mix the profits from their business with their personal funds in one account, primarily out of ignorance than from an intended choice. It seems convenient, or harmless to commingle funds in one consolidated account, and be absolved from managing multiple accounts. This may be most common among solopreneurs working from a home-based business, and especially those who are still working a full-time job, than from those operating a bricks and mortar, where the management of numerous overhead costs requires a more structured and efficient accounting process. There are several key disadvantages of consolidating your personal and business assets:

- Ineffective separation of personal funds from profits generated by your business
- 2. No clear understanding of what the business generated, so you can't measure progress from revenues the business generated
- Charging from your checking account for personal items depletes funds generated from your business
- 4. Ineffective accounting of inflows and outflows; No proper financial control and accountability
- 5. It is difficult to understand your business' cash position and working capital
- 6. Bad cash management will lead to no cash for growing your business operation

- 7. Tax filing will be difficult, if you can't account for what the business generates, and the IRS may initiate an audit, if they suspect any discrepancies in your accounting
- 8. Poor financial management overall could lead to business failure and eventual closure



It may be very tempting to use money generated from your business to purchase personal items unrelated to the business, but this is not advised. All profits generated from your business should be placed in a separate account, and from which you can pay yourself a salary. Establish a business checking account, for which you will be issued a business debit card and checks to use for your business transactions. All of your business transactions should be kept separate from your personal transactions. Many banks offer free business checking and great plans for establishing business savings accounts, especially assisting you in setting up merchant accounts to better manage your business assets. Being organized as a small business owner is essential to keeping yourself on the right path to properly managing your business and remaining solvent, especially if you do not have an accountant to oversee the business' financial functions. If you are working a full or part-time job, or have the capital to support yourself, and you can withstand paying yourself a salary until your business reaches an increased milestone in sales, the revenue you make from providing services or selling products should be kept completely separate in its own account. When you are purchasing supplies for your business, execute those purchases from your business account. If you are at a retail outlet, and you are purchasing casual clothes unrelated to your business needs, use your personal debit card for this. Groceries or any item for personal use should be purchased with funds from your personal account, and not with funds generated from your business. Business funds are for business related items.

In summary, keep your accounts separate to mitigate any complexities in differentiating from what you classify as personal from what you classify as business. With free business checking offered by some banks, you can establish an account and relationship with one of many institutions to properly manage your finances and not commingle your funds.

International Policy and Business Strategies: Griffith Global Initiatives

Takes Off

professional endeavors as he moves on from managing the day-to-day business affairs of Fort Valley State University. Dr. Griffith will be stepping down as the University's President on June 30, 2015. Over the 2 year tenure of his Presidency, Dr. Griffith's most prominent areas of success were establishing a Global Initiatives Council of scholars and academicians, businessmen and women, students, and faculty to increase international engagement, launched an annual International Cultural Festival as a component to increase international recruitment along with the global initiatives, completed feasibility analysis for new Food Science and Logistics and Supply Chain Management degree programs, and a School of Entrepreneurship and Business Innovation, filled key staffing positions, enhanced the university's social media marketing

initiatives, achieved a 176% increase in admitted students from 2014 to 2015, signed Memorandums of Understanding (MOUs) with four junior colleges in the middle Georgia area for the transfer of students to Fort Valley State University upon completing their 2-year degrees to further their undergraduate studies, and numerous additional accolades over this short period too lengthy to list in this article. The Honorable, Dr. Kenny Anthony, Prime Minister of St. Lucia, received an Honorary Doctorate Degree during the first commencement ceremony over which Dr. Griffith presided on December 7, 2013, and at which, Dr. Anthony was the keynote speaker.

Dr. Griffith is a unique visionary, with a strong background in higher education leadership, international security, policy advisement on counter-crime and counternarcotics in the developing world, and in other areas, who came to Fort Valley State University with several goals in mind to include growing the struggling university's global influence, make the obscured middle Georgia university a more competitive BRAND, and position the institution as a top choice among its regional competitors. He was on pace to make Fort Valley State University a world class institution to compete globally with other international renown universities in the state of Georgia and the U.S., and one in which the entire Fort Valley community and alumni would have profound fondness. Dr. Griffith's background included, and prior to becoming a university President, Provost of York College of the City University of New York, Budget Dean of the College of Arts and Sciences at Florida International University, Provost at Radford University, and Dean of the Honors College at Florida International University. His travels while at Fort Valley State University included, but were not limited to speaking with various Heads of States in the Caribbean, and addressing the Parliament of the Government of Guyana on potential partnerships with Fort Valley State University. Although he has been called to pursue other opportunities, Dr. Griffith leaves a strong legacy at Fort Valley, which was recognized widely by the Fort Valley State University National Alumni Association, Inc. during A Leadership Appreciation Reception held in Macon, Georgia honoring Dr. Griffith and First Lady Francille Waveney Griffith on June 13, 2015 for his transformational leadership and achievements at the university. Many speeches and endearing words of praise were delivered, and all in admiration of his tremendous investment made as President of the university. Dr. Griffith was presented with numerous gifts, which included a Fort Valley State University Lifetime Alumni Membership.

The event was attended by alumni members, university faculty and staff, Mayor Barbara Williams of Fort Valley, Georgia, representation from the City of Warner Robins, Georgia House District 139 Representative Patty James-Bentley, 114th Congressional District Congressman Sanford D. Bishop, Jr., Representation from the City of Macon, Georgia, the newly appointed Interim President of Fort Valley State University, Ms. Jessica Bailey, and numerous other illustrious invited guests.

On his new journey, Dr. Griffith will be moving his global initiatives forward to work with universities, corporate entities, governments, and numerous organizations in a consulting capacity. 
